- v. **Spirit Life – Sam R. – Present**
  - i. No current issues. Estimated 35 residents in attendance. Looking for more panel leaders and support to help with the commitment. Was only able to provide a H&I meeting once this month due to work. Notified the facility so they were aware no meeting would take place that evening.
- vi. **SCI Somerset – Larry P.– Absent**
  - i. 20 inmates attend. Topic discussion – Steps 1,2,3; Tradition 1,2,3; Chapters 1,2,3 out of Basic Text; IP's; Burning desires related to NA. Meeting is held every other Wednesday from 2:30pm-3:30pm. Included two copies of the receipts received at SCI Somerset. One from ECCNA and one from LMHANA. Still working on reaching out behind the walls.
- vii. **Somerset County Jail – Joe H. – Point of Contact**
  - i. Anywhere from 1-7 inmates attend and it is a literature study meeting. Was unable to provide meeting the last 2 times due to not having 2 panel leaders to take the meeting in. In need of men and women to get involved and become panel leaders. Please announce at homegroups.

- ix. **Bedford County Jail – Vacant**
  - i. Lance gave the report and is the point of contact for the facility. Meeting gets 4-8 inmates and is a literature discussion. Men's meeting is held the 1<sup>st</sup> and 3<sup>rd</sup> Wednesdays of the month. Women's meeting is on the 4<sup>th</sup> Wednesday of every month. Recently moved to a bigger room. The commitment needs women volunteers.

  - i. Unable to continue to be the panel coordinator due to serving the last 2 years. Willing to continue to be the point of contact until another member steps up. Two applications were turned in and approved, now just waiting on the orientation process.

need of panel leaders for the women's side. Women side have not had a meeting in a month due to jail being on lockdown and not having another NA member willing to take in meeting. Lieutenant is looking into seeing about allowing inmates to have literature.
